1st page, the October 2020 JOM Budget Summary/Reimbursement Form. Total Budget for is \$68,726.83-Budget Column 1. Column 2-No modification. The totals in Column, 3-Amended Budget equals \$68,726.83. Column 4-Total Invoice reimbursement for month of October 2020 is signed by Ms. Patricia Marquez in the amount of \$17,017.30. Invoice for Salaries \$2,821.02, Fringe Benefits \$722.87, IEC mileage/stipend \$200.00 and Instructional Supplies \$13,273.41. The expenditures in Column 4 are reflected in Column 5-Year-To-Date in the amount of \$24,909.67. Column 6-Budget Balance is \$43,817.16. The 2<sup>nd</sup> page, The Personnel Listing page are expenditures for Director, Secretary, NYA-Salaries and Fringe Benefits in the amount of \$2,821.02 with YTD expenditures of \$8,124.16. The 3<sup>rd</sup> page, Disbursements for the month ending October 2020 is in the amount of \$17,017.30. Expenditures for Payroll/Fringe Benefits \$3,543.89, IEC mileage/stipend \$200.00 and Blusource for Instructional supplies \$12,902.95, Staples Advantage for Instructional supplies \$370.46.

**B. JOM Contract – Status and Budget Modification**

The \$7,223.59 balance from last school year's budget was not approved therefore the anticipated budget to include in this year's contract as "carryover" had to be adjusted. Ms. Beverley Tsosie will submit a Budget Modification to cover the negative amount in budget line item #312 Instructional supplies in the amount of \$6,153.83. Ms. Beverley Tsosie also indicated the salary and fringe benefits line item will be in the negative soon as the amounts budgeted only covers for 1 NYA. The budget modification will include both adjustments to alleviate possible negative amounts in the current budget.
